Proposal Contents

Proposals must provide the following information:

- Session or workshop title: A short and catchy title that accurately reflects the focus of the session
- Abstract: A short description of the session, relevance to conference topics and what people can expect to learn (100 words maximum)
- Presenter's identification & expertise: Provide the name, title, address, phone number, fax and e-mail address for each presenter. Describe the relevant expertise of each presenter to the session topic (1 page maximum).
- Describe the audio-visual needs of the session. Internet connections are not available. Many session rooms are not "AV Friendly".

Review of Proposals

The CCAPA 2006 Programs Committee will evaluate proposals on:

Overall quality and originality
Relevance to conference themes
Clarity of focus

Practical solutions and application
Presentation skill of speakers

Speaker Guidelines

If you are selected to present at the CCAPA 2006 Conference you will be required to follow the speaker guidelines below:

- Moderators and Panelists will receive Complimentary registration to the Sessions on the Day of their Presentation ONLY. This does not include meals and meal tickets and/or additional conference registration must be purchased separately.
- All Moderators and Panelist MUST register even if they are only speaking on the Day of their Presentation
- Badges must be worn at all meal functions and a receipt must be presented
- Moderators/Panelists must comply with the CCAPA Program Chair's request for Bio's/Session Topics in the format requested for the final program and by the deadline of August 1, 2006. Failure to turn bio's/topics in by the deadline and format requested will result in the Committee's discretion to use the most current submittal.
